Understanding the impact of pandemic, PHO suggest that the crew to have 14 days incubation period upon his arrival and then undergo COVID19 test, if he is travelling from long distance, which may avoid any issues on board later. Offsigner to undergo COVID19 test by following 14 days quarantine period (time to count from the time of vs! sailing from Foreign Load Port). For Coastal vessels COVID19 test may be carried out upon disembarkation of the crew from vessel. At Chennai - Port facilitated with 6 isolated rooms + Sea Farers Club to be utilised. At Ennore Port - PHO advised to avoid Indian crew change time being as he is in the process of making necessary arrangements and revert once it is ready. Foreign Crew - Under emergency, only sign off allowed by immigration with the permission of Port Health officer. Offsigner require to undergo quarantine/isolation as needed.
